INSIDE
A VEHICLE BY A PASSERBY.

ELINA WEISBERG (WITNESS/PASSERBY) STATED THAT AS SHE WAS WALKING ON THE SIDE WALK NEAR THE SHELL GAS STATION SHE, OBSERVED A VEHICLE EXITING AND A PHYSICAL ALTERCATION ENSUE INSIDE THE VEHICLE BETWEEN A MALE LATER IDENTIFIED AS ABNER BRILL KURTIN (DEFENDANT) AND A FEMALE LATER IDENTIFIED AS SAVANNAH ROSE SIEJKA (VICTIM) INSIDE A LIGHT BLUE IN COLOR MERCEDES BENZ G63 BEARING FL TAG: 62AAZ.

WEISBERG STATED SHE OBSERVED KURTIN WHO WAS IN THE DRIVER SEAT OF THE VEHICLE AT THE TIME OF THE INCIDENT STRIKING SIEJKA (FRONT PASSENGER SEAT) AND THEN GRABBING HER HEAD AND STRIKING IT AGAINST THE DASHBOARD OF THE VEHICLE.

WEISBERG STATED SHE OBSERVED SIEJKA WITH HER HANDS UP TRYING TO AVOID GETTING HIT BY KURTIN.

AS OFFICERS ARRIVED TO 41ST STREET AND ROYAL PALM AVE THEY WERE UNABLE TO LOCATE THE VEHICLE.

A RECORDS CHECK WAS LATER CONDUCTED AND DISPATCH PROVIDED OFFICERS WITH THE LOCATION OF THE OWNER THE VEHICLE WAS REGISTERED TO.



OFFICERS RESPONDED AND LOCATED THE VEHICLE MATCHING THE DESCRIPTION PROVIDED BY WEISBERG.

OFFICERS WERE ABLE TO MAKE CONTACT WITH SIEJA AS SHE WAS MAKING HER WAY UP TO HER APARTMENT. SIEJKA TOLD PD THAT HER AND KURTIN WERE INVOLVED IN A VERBAL ALTERCATION BUT SHE STATED SHE WAS FINE AND NOTHING ELSE HAPPENED.

IT SHOULD BE NOTED THAT OFFICERS OBSERVED A SMALL BUMP TO SIEJKA'S LEFT SIDE OF HER FOREHEAD BUT SHE CLAIMED IT WAS A PIMPLE AND ANOTHER SMALL BUMP TO THE UPPER LEFT EYE.

IT SHOULD BE NOTED THAT THERE WERE NO VISIBLE INJURIES OBSERVED ON KURTIN.

OFFICERS MADE THEIR WAY UP TO KURTIN'S APARTMENT WHERE THEY WERE ABLE TO MAKE CONTACT WITH HIM. KURTIN ALSO STATED THAT THEY WERE BOTH HAVING A VERBAL ALTERCATION INSIDE THE VEHICLE, SIEJA GRABBED HIS PHONE AND HE PUSHED HER ARM AWAY BUT DENIED EVER... [Continued on Next Page]

MIAMI BEACH FIRE RESCUE 1 RESPONDED TO THE FIRST FLOOR OF THE MBPD GARAGE WHERE KURTIN WAS EVALUATED AND TRANSPORTED TO MOUNT SINAI FOR FURTHER EVALUATION PRIOR TO BEING TRANSPORTED TO TGK.
